Notice regarding matters concerning the extension of the tax declaration period in April

Provinces, autonomous regions, municipalities directly under the Central Government of the State Administration of Taxation, and municipalities separately planning the State Administration of Taxation, State Administration of Taxation's special commissioner's offices in various places, and units within the bureau:

In order to further support the epidemic prevention and control work and the resumption of production of enterprises, and to facilitate taxpayers and withholding agents (hereinafter referred to as taxpayers) to handle tax

declaration matters, the State Administration of Taxation has decided to extend the tax declaration period in April 2020. The relevant matters are now notified as follows :

1. For taxpayers reporting on a monthly or quarterly basis, the tax declaration period will be extended nationwide from April 20 to April 24; Hubei Province may extend it as appropriate according to circumstances. Hubei Provincial Taxation Bureau is clear according to law.

2. Due to the impact of the epidemic situation, taxpayers who still have difficulty in applying for declaration within the tax declaration period in April 2020 may apply to the tax authorities for extension of declaration.

The local tax authorities should follow the instructions carefully and report any problems to the State Administration of Taxation (Department of Taxation Management and Technology Development) in a timely manner.
