THEME : Notification of provisions of article 52 L.4701 / 2020 (Government Gazette A 128 / 30.06.2020)

We inform you, for information and implementation, of the provisions of article 52 of Law 4701/2020 (Government Gazette A 128 / 30.06.2020) "Microfinance granting framework, financial sector regulations and other provisions" which amend paragraph 4a of article 29 of Law 2960/2001 "National Customs Code".

In the context of strengthening the transit trade and utilization of the geographical position of our country, with par. basis for the movement of their goods in EU countries and other international markets with suspension of payment of import VAT since almost all of these goods are destined for foreign markets. In this way, the country's major ports and their infrastructure are used as entry points for goods from third countries, warehouses,

The companies not established in our country enjoy the above privileges through obtaining a relevant license which is issued by the A.A.D.E. with the terms and procedure of POL.1126 / 2013 A.Y.O after checking strict reliability criteria such as compliance history, financial solvency, etc.

"PRE-PUBLISHING - HAS NOT RECEIVED AD"

With the notified provision, the annual limit for inclusion in the VAT suspension regime is adjusted to 40 million euros per year, regardless of the year of entry of those interested in the scheme, in order to meet the dynamics of business groups wishing to operate in our country.
